This unique patent-pending formula is the result of 3 years of research. Clinical trials prove that HMD™ effectively eliminates toxic heavy metals such as mercury, lead and even uranium from your body.



HMD™ is made from 100% natural, organic ingredients and is suitable for vegetarians and vegans. It is free from allergens, artificial colouring, flavours, salt or preservatives. HMD™ contains Cilantro (*Coriandrum sativum*), a homaccord of Chlorella and Chlorella Growth Factor (CGF).

Unlike other chemical chelators, HMD™ has no known side effects and is safe for the entire family. HMD™ will give you more energy, make you feel better and eliminate or alleviate all symptoms associate with metal toxicity such as migraines, fatigue, allergies, irritability and mood swings.



# SCIENTIFIC PROOF:

HMD™ is the **ONLY 100%** natural heavy metal detox product that has undergone **extensive testing** and has been **scientifically proven** to work. Unlike many other detox products, HMD™ has **no major detox side effects**. There simply is no other product like it on the market today!

HMD™ is the result of a three-year long research that cost over \$1 Million. During those 3 years over 25 different natural products and combinations were scientifically tested and the only combination that managed to eliminate the most toxic heavy metals is now known as HMD™.

## HMD™, THE GOLD STANDARD OF RESEARCH

The HMD™ research followed rigorous scientific protocol known as the “Gold Standard” of scientific testing: The “double-blind, placebo-controlled” protocol.

350 people were tested. Some were given a harmless substance with no active ingredients. This is known as a “Placebo”. In a placebo controlled study the test subjects who received the actual medicine, must perform significantly better than the people who received the placebo.

In our testing none of the test subjects knew whether they were receiving HMD™ or just a Placebo. Neither did the researchers nor the laboratories know what/who they were testing. Hence the name “double-blind” – it ensures that results are not contaminated in any way by prejudice or belief.

Samples of both urine and faeces were taken from the subjects before (baseline) and after (post) taking the HMD™, and the levels of metals were tested in each of these samples. These samples were sent to laboratories in the US where ICP-MS cutting-edge spectrometers were used to analyse the samples to an accuracy of parts per billion. A “detoxifier” [substance that removes heavy metals from the body] works if metal levels are higher in the “post test” [sample taken after the remedy was ingested].

After the initial studies further tests were done to prove HMD™’s effectiveness for removing Mercury as well as Uranium.

Uranium-238 is a growing worldwide problem due to depleted uranium missiles used during wartime. HMD™ is the only natural detox product capable of removing Uranium 238.

The results show that after only a 12-hour provocation with HMD™ there were many heavy metals eliminated in the post-urine and faeces samples, compared with baseline (figures are expressed as a % mean increase):

- Mercury – 448%
- Lead – 483%
- Arsenic – 7,409%
- Uranium – 707%
- Antimony – 45%
- Cadmium – 67%
- Bismuth – 564%
- Nickel – 80%

HMD™ has been dubbed the ‘**gentle detoxifier**’ due to its lack of detox side effects. While some people experience minor detox symptoms such as headaches during the first 24 hours, no major side effects have been reported. Experiencing some form of detox symptoms is usually a good sign – it means that the product is working as the body is reacting to the toxins that are being removed from storage sites in tissue and organs. This effect has been dubbed the ‘Healing Crisis’.

Unlike synthetic chelators which can cause serious side effects such as kidney failure, HMD™ has no adverse effects on the detoxification organs. During the clinical trials we also tested kidney, liver and heart functions before, during and after taking HMD™ and no adverse reactions were found. On the contrary, the HMD™ research indicated an improvement in bodily functions. Heart Rate Variability Testing (HRV) – a measure of the functionality of all the physiological systems of the body – showed a significant improvement.



**HMD™ is 100% natural and 100% effective.** It is a blend of **natural ingredients** that has been scientifically proven to eliminate heavy metals from the body. It is important to note that taking all the HMD™ ingredients **on their own** will not achieve any detoxifying [metal binding] effects. Only when mixed together in a special ratio are they effective. It has taken \$1 million dollars and 3 years of extensive research to find the unique patent-pending HMD™ formula that eliminates the most harmful heavy metals and toxins from the body.

HMD™ is a completely natural detox product: It is a synergistic blend of herbal ingredients such as Chlorella Growth Factor, Coriandrum sativum (Coriander) and a homaccord of Chlorella pyrenoidosa.

In order to further support and enhance the body cleansing process we have also developed the special drainage remedy 'HMD™ LAVAGE' and the special 100% toxin-free HMD™ CHLORELLA.

## CHLORELLA GROWTH FACTOR:

Chlorella Growth Factor (CGF) is a steam distillation extract of chlorella pyrenoidosa. Chlorella Pyrenoidosa is a species of fresh water green algae. Chlorella has many health benefits and helps the body to detoxify. In animal studies it has been shown to remove some toxic metals.

CGF is rich in neuropeptides which are small molecules that influence brain activity. These have been shown to latch on to metals and eliminate them through the urinary tract.

Cilantro or Coriandrum sativum is a herb commonly known as coriander. Our Cilantro is a natural tincture made from organic coriander leaves. It is a vegetable glycerin extract. While cilantro tincture used by itself can actually cause the body to hold on to metals rather than eliminate them, when used in our special synergistic mixture, it has the opposite effect.



## HOMACCORD OF CHLORELLA PYRENOIDOSA:

A homaccord of Chlorella Pyrenoidosa is a homeopathic mixture of chlorella of different potencies.

## HMD™ ULTIMATE DETOX PACK

Chlorella, by itself, is not an intracellular chelator, so will not pull heavy metals from inside the cells. It will only pick-up heavy metals and other toxins from outside the cell, either from the mesenchyme or the gut and sacrifice itself out of the body.

This is why we recommend the HMD™ ULTIMATE DETOX PACK for chelating, mobilizing and eliminating toxins from the body. It is really an ultimate detox pack in many ways as the HMD™ will chelate metals from inside the cells, while the HMD™ LAVAGE, which is a herbal drainage remedy, will open up the detoxification organs, therefore enabling toxins to be eliminated at the same time.
